

Licensed Alcohol and Drug Counselor, Full Time, **Owatonna, Minnesota**

The Dual Recovery Program is seeking a professionally minded, Licensed Alcohol and Drug Counselor for a full-time position located in Owatonna, Minnesota. The position requires a working knowledge of; co-occurring disorders and the effects of psychopharmacology for dually diagnosed clients. The Dual Recovery Program is a MS 245G licensed, co-occurring non-residential treatment program which coordinates with mental health professional providers and in association with a three-county mental health clinic.

The position involves working with; adult men and women who are diagnosed with mental health and substance use disorders in gender-specific and mixed-gender groups as well as individual sessions. This position tasks include; completion of initial and comprehensive assessments, on-going progress notes, treatment planning, treatment coordination, working with family members, other outside referrals and the ability to document within the electronic health record (EHR).

The candidate must be licensed or licensable as an LADC, pass a background check and work independently as well as with the treatment team.

This is a full-time position Monday-Fridays 8 am-5 pm.

The position requires licensure with the Minnesota Board of Behavioral Health and Therapy as an L.A.D.C.

SUMMARY

Each client admitted to the Dual Recovery Program is assigned a Substance Use Counselor for the purpose of serving as a treatment team liaison. The Substance Use Counselor takes the responsibility for coordinating the following: assessment and identification of client's needs; coordination of the development of the treatment plan; and facilitation of the discharge planning process. In addition, the Substance Use Counselor serves as the client's guide, confidant, advisor and advocate and assists the client in identifying problems that need to be addressed.

PRIMARY RESPONSIBILITIES

To ensure that each client has a Substance Use Counselor who is responsible for client's treatment process as well as serving client with consultation and guidance throughout treatment.

Procedure:

- A. The Substance Use Counselor will serve as primary counselor for Dual Recovery Program clients.
- B. The Substance Use Counselor is responsible to provide the following services directly or in cooperation with other staff members and to ensure that the services are provided by another staff member. At times when the Substance Use Counselor is gone another staff member will be designated as the Substance Use Counselor.
 1. Conduct all duties in an accountable, punctual, timely and professional manner.
 2. Review the comprehensive assessment in order to fully understand the client and define those problems particular to the client.
 3. Meet with the client's family and/or significant others as appropriate. Educate and offer suggestions for how they can best support the client's recovery program. Make referrals to community resources as needs are assessed.
 4. Coordinate the development of Individualized Treatment Plans including identification of problems, objectives and treatment methods with the client.
 5. Documentation of regular progress notes to reflect progress in achieving treatment objectives.
 6. Facilitate communication with the team regarding the client by presenting the case history and treatment plan at clinical staffing.
 7. Supervise and monitor the completion of treatment plan assignments for the client.

8. Serve as the primary group therapy facilitator.
9. Meet with the client in accordance with MS 245G for individual counseling and treatment plan assessment including providing education to clients and to promote a recovering lifestyle.
10. Update treatment plan according to client's treatment progress and needs throughout the treatment process and document in treatment plan section in client's chart.
11. Coordinate, facilitate communication for the client with attorneys, probation officers, mental health providers, etc. and document all communication in client file.
12. Refer client to appropriate resources for support after discharge from the program.
13. Facilitate development of a comprehensive discharge plan for the client and the family.
14. Discharge plans need to be completed within five (5) days of discharge from the program.

SECONDARY RESPONSIBILITIES

Performs miscellaneous projects and completes various tasks as requested by management.
